How do we store your data?

Amrut securely stores your data at secure locations (Cloud, On Premises). All locations are Secure as per ISO standards.

Amrut will keep your Private data for 3 years. Once this time period has expired, we will delete your data by automated scripts.

If you have agreed to receive marketing, you may always opt out at a later date.

What are your data protection rights?

The right to data portability – You have the right to request that Amrut transfer the data that we have collected to another organization, or directly to you, under certain conditions.
